- No interference/ interaction with Jarawas tribes during the course of work. iii)
- NHIDCL shall ensure that no tobacco (pan/gutka), cigarette, alcohol, match box, lighter or any other inflammable articles shall be carried by any person during the course of work.
- They shall deposit the mobile phone, or any camera with the Police Outpost, Jirkatang. No photography shall be allowed in the Jarawa Reserve Area.
- The team shall be escorted with AAJVS/ Police/Forest and carry out the project work under their supervision
- ATR convoy system shall not be disturbed at any cost.
- NHIDCL shall ensure close monitoring of persons who will be engaged in the project of the ATR road.
- ix) The time of entry and departure shall be entered in the log book maintained by . the Palice.
- Necessary tribal pass/movement pass from the District Administration shall be obtained to enter the Jarawa Reserve Area.

NHIDCL shall issue necessary instructions to each person for strict adherence and compliance of the above terms and conditions without fail.
