v) NHIDCL shall ensure that no (pan, gutka) tobacco, cigarette, alcohol, match box, lighter or any other inflammable articles shall be carried by any persons during the course of work.

vi) They shall deposit the mobile phone, or any camera with the Police Outpost, Jirkatang. No photography shall be allowed in the Jarawa Reserve Area.

vii) The project work shall be carried out under the overall supervision of AAJVS/ Forest/ Police

viii)ATR convoy system shall not be disturbed at any cost.

ix) The road passing through Jarawa Tribal Reserve shall not be disturbed.

x) NHIDCL shall ensure close monitoring of persons who will be engaged in the project of the ATR read.

xi) The team shall be escorted with AAJVS, Forest officials and Police personnel.

xii) They shall enter the time of entry and departure in the log book maintained by the Police.
xiii) Necessary tribal pass from the District Administration shall be obtained to enter the Jarawa Reserve no contact work
