- After completion of the survey, a report should be submitted to this office. 7.
- This permit is liable for cancellation in the event of violation of any provision of the 8.
- They should obtain the tribal area entry permits from the Deputy Commissioner, South 9. Andaman/Nicobar District for entering the tribal Reserve Area at South Andaman island, Middle Andaman island and Nicobar District.
