

**STATEMENT OF CONDITION**

1. The Pass Holder may visit the said reserved area and remain therein during the period of validity of this PASS for following purpose and shall,after the expiry of such period, surrender this PASS to the Officer-in-Charge of nearest police station or to the nearest Magistrate and, if this PASS is lost , a report of such loss shall be made by the pass holder forthwith to said Officer-in\_charge or the said Magistrate, Namely(DC(N))
- 2.The pass holder shall not carry on or engage himself in any trade or business in the said reserved area except to the extent,if any, authorised by this PASS.
