Purchase of 100 Nos. charge controllers high frequency inverters for tube lights, light fittings for SPV street and domestic lighting systems. Purchase of 20 Nos. SPV Street/ Domestic Lights and its distribution to beneficiaries as per the MNES subsidy pattern and at an U.T subsidy of 25% of cost.
