course is July 2006 to April 2007. Additional Scholarship to the ST students for the period from July, 2006 to March, 2007 of the JNRM Port Blair and MG College, Mayabunder, have already sanctioned vide office Order No. 24 dated 19.01.2007 and Order Nos. 73, 74, 75, 76, 77 and 78 dated 16.03.2007, Order No. 104 and 105 dated 27.03.2007 and Order No. 244 dated 21.06.2007 placed at page 25-44/cor. and 50-51/cor. and has been disbursed to the ST students. Additional scholarship for the month of April 2007 is due for disbursement to the ST students. The attendance statements in respect of the ST students of JNRM, Port Blair and MG College, Mayabunder are placed in the file at page 95 to 101/cor. Accordingly the department has now proposed for payment of additional scholarship for the month of April, 2007 to 129 ST students (i.e. 110 ST students of JNRM + 19 ST students of MG College). As approved by the Govt. of India, Ministry of Tribal Affairs vide letter dated 05.06.2006 and 10.07.2002 placed at page 45 and 102/cor., the tribal students are eligible for additional scholarship @ Rs. 500/- per month. Thus an amount of Rs. Rs. $64,500/-(129 \text{ St students } \times \text{Rs. } 500.00 \times 1 =$ Rs. 64,500.00). A provision of Rs. 6.00 lakh is available under the Scheme No. 2, "Welfare of SC, STs & OBC" in the Annual plan, 2007-08, copy placed at page 103 to 106/cor.
